INCREASE IN AUTHORISED SHARE CAPITAL OF THE COMPANY AND ALTERATION OF CAPITAL CLAUSE OF MEMORANDUM OF ASSOCIATION OF THE COMPANY

To consider and, if thought fit, to pass with or without modification(s), the following Resolution as an **Ordinary Resolution**:

"RESOLVED THAT pursuant to the provisions of Sections 13, 61 & 64 and other applicable provisions, if any, of the Companies Act, 2013, (including any statutory modification(s) and re-enactment(s) thereof for the time being in force) and the rules framed thereunder, consent of the Members be and is hereby accorded to increase the Authorized Share Capital of the Company from Rs. 35,00,00,000/- (Rupees Thirty Five Crore) divided into 1,50,00,000 (One Crore Fifty Lakh) Equity Shares of Rs.10/- (Rupees Ten only) each and 2,00,00,000 (Two Crore only) Preference Shares of Rs. 10/- (Rupees Ten only) each to Rs 42,02,00,000/- (Rupees Forty-Two Crore Two Lakh) divided into 2,20,20,000 (Two Crore only) Preference shares of Rs.10/- (Rupees Ten only) each to Rs 10/- (Rupees Ten only) Equity Shares of Rs.10/- (Rupees Ten only) each and 2,00,00,000 (Two Crore only) preference shares of Rs.10/- (Rupees Ten only) each and 2,00,00,000 (Two Crore only) Equity Shares of Rs.10/- (Rupees Ten only) each and 2,00,00,000 (Two Crore only) each to Rs 42,02,00,000/- (Rupees Ten only) Equity Shares of Rs.10/- (Rupees Ten only) each and 2,00,00,000 (Two Crore only) preference shares of Rs10/- (Rupees Ten only) each.

To consider and if thought fit to pass, with or without modification(s), the following resolution as a **Special Resolution:**

RESOLVED FURTHER THAT in terms of the provisions of Chapter V of the SEBI ICDR Regulations, the Relevant Date for determining the floor price for the preferential issue of the warrants is **Friday**, **June 02**, **2023**, being the date 30 days prior to the date on which the meeting of shareholders i.e. Extra Ordinary General Meeting is held to consider the special resolution of the preferential issue.
